

Note:

War invalids and members of the Association of Martyrs and Fallen Defenders have free entry upon presentation of an ID card.

For groups of 25 or more visitors, free entry is granted for the group guide and the bus driver. Tickets are valid for one day.

The ticket price for individual visits includes the price of a full-day tour of the Štrbački buk-Lohovo visitor zone using the roads and trails marked with tourist signage, as well as the roads and trails shown in the promotional material that each visitor can request with the ticket.

Ticket price at entrance no. 5 in Martin Brod includes a tour of the waterfalls, i.e. Milančevo Buk. Visitor insurance is included in the ticket price.

The local population living in the Park, i.e. in the local communities of Kulen Vakuf and Martin Brod, has free entry to the visitor zone Martin Brod-Milančev buk, and the residents of MZ Orašac to the visitor zone Štrbački buk. Entrance to the visitor zones is not charged to persons who have real estate in the Park's visitor zones in terms of unhindered access to them. Persons previously unknown to the employees of JP NP Una d.o.o. as residents or owners of real estate in the Park or rarely visit these zones, they are obliged to prove their status at the entrance to an authorized person by means of an identity document and/or a document of ownership.

Journalists with an official photo ID (PRESS), as well as tour guides and bus drivers from agency groups who are registered with the Una National Park administration, have free entry to the visitor zones.

All female visitors, who are called UNA, have free entry to the visitor zones of the National Park upon presentation of a valid photo ID.

Sales can be made exclusively at specific locations and places at the standardized stands of the Una National Park with a signed contract with JP Nacionalni park Una d.o.o. and the Rulebook on

the rental of stands, the manner and types of sale of goods and services, which lessors are obliged to comply with in accordance with the signed contract.

- * Daily stand rental is done without a contractual relationship and at a stand that is free for use on a certain day. The rent is paid at the entrance booths to the visitor zones and the lessee, by renting a wooden stand for one day, users accepts the regulations and rules of conduct according to the Rulebook on the rental of stands, the manner and types of sales of goods and services.
- * * Selling "at the doorstep" means renting a stand to residents of NP Una for the sale of products prepared and grown in their own household. It applies exclusively to sales in yards and on private land near roads, but not to sales on public areas without approval.
